# REFERRAL REWARD POLICY

### 1. Introduction

50KCY Ltd, previously 50CoinsCY Ltd, (the "Company", "we" or "us") is a Cypriot Investment Firm licensed and regulated by the Cyprus Securities and Exchange Commission ("CySEC") under license number 282/15.

- 1.1. This policy (the "Policy") governs the Referral Reward Program (the "Referral Reward") offered by us to existing clients who refer new clients ("Referrals") to the Company in exchange for a reward.
- 1.2. By participating in this promotion, You acknowledge and agree to abide by this Policy, by its terms and any other applicable terms related to your trading account and as amended from time to time.
- 1.3. The start date of the Referral Reward is 1st September 2025 (the "Start Date").

# 2. Definitions

- **Referrer**: An existing 50K client who refers new clients and receives rewards.
- **Referral**: A new client who registers with 50K using a Referrer's unique referral link or applies the Referrer's ID in the app.

# 3. Eligibility

- 3.1. The Referral Reward is available to existing 50K clients, who have completed the onboarding process and have their trading account successfully verified, and who generate a unique referral link.
- 3.2. To qualify for the reward, the Referral referred by the Referrer must:
  - Be a new client of the Company.
  - Register with 50K using a Referrer's link or ID code.
  - Complete the onboarding process and have their trading account successfully verified.
  - Make a first-time deposit ("FTD").
- 3.3. If a Referral withdraws deposited funds within 30 days of the first deposit, the Referrer will not receive the reward.

- 3.4. A Referrer cannot refer family members or individuals from the same household (determined by shared addresses, devices, or IPs).
- 3.5. The Company's employees or any other associated people are not eligible for the Referral Reward.
- 3.6. Referral may only be registered and create an account in accordance with the Company's applicable terms, policies and procedures.

#### 4. How It Works

### 4.1. Generating a Referral Link

- Any 50K client can generate a personal referral link.
- Once generated, the link can be copied and shared with potential Referrals.

### 4.2. Referral Link Rules

- Each referral link grants eligibility for a maximum of 15 Referral Rewards.
- The Referrer cannot use their own link for self-referral.

# 4.3. Late Assignment of a Referrer

- A Client may manually assign a Referrer after opening a real account by entering the Referrer's User ID.
- Manual assignment is only allowed if none of the Client's accounts are already linked to another Referrer.

# 4.4. Referral Reward

- The Referrer shall receive 200 Euros<sup>1</sup> worth of "Trading Credits" per eligible Referral.
- The Reward shall be credited only after the 30-day qualification period ends.

# 5. Trading Credit Allocation and Usage

5.1. The Trading Credit is a cash sum credited to your trading account. It is for trading purposes only and cannot be withdrawn.

- 5.2. Any profits generated using the Credit can be withdrawn, subject to our standard terms and withdrawal procedures. For more details, please refer to the withdrawal section in the <u>FAQ</u> on our website.
- 5.3. The Credit is non-transferable and can only be used by the account holder to whom it is issued.
- 5.4. Profits generated from Trading Credit are typically withdrawn via Wire Transfer. Withdrawals below 100 EUR may incur a 10 EUR fee.

# 6. Expiration of Trading Credit

- 6.1. The Trading Credit will expire on the 21<sup>st</sup> day from the date it is granted, or immediately upon making a withdrawal. It is your responsibility to monitor these schedules. You will be notified in advance via an in-app message before each expiration date.
- 6.2. Once expired, the Trading Credit will be removed from your account balance.
- 6.3. The removal of the Trading Credit may affect any open positions at the time of the expiration.

# 7. Referral Integrity

- 7.1. The referral link must be shared in a fair and ethical manner.
- 7.2. Referrers must not engage in misleading marketing tactics, such as false profit guarantees or avoidance of referring to the risk involved.
- 7.3. Clients referred must be genuine, and duplicate or fraudulent accounts will not qualify for rewards.
- 7.4. The Company reserves the right to cancel or withhold rewards if it detects duplicate accounts, self-referrals, or any behavior violating this policy.
- 7.5. The Company may suspend rewards if the Referrer promotes the referral program in unauthorized ways.
- 7.6. Referrers should not use Company's logos and/or other elements that are considered as Company's intellectual property.

# 8. Quality Standards for Referral Rewards

- 8.1. If a Referral is found to be misusing the platform, or not meeting the Company's engagement criteria, the Referrer may not receive the reward.
- 8.2. The Company reserves the right to withhold rewards if it identifies violations of referral policies.

### 9. General Conditions

- 9.1. The Referral Reward is offered at the Company's sole discretion and may be modified, suspended, or terminated at any time without prior notice.
- 9.2. The Company reserves the right to revoke the Reward if a Client is found to be in violation of this Policy, the trading account terms, or any applicable laws and regulations.
- 9.3. Fraudulent activities, misuse of the Referral Reward, or any action deemed harmful to the Company will result in immediate disqualification and potential further action.
- 9.4. Participation in this promotion does not establish any partnership, agency, or joint venture between You and the Company.
- 9.5. Referrers should not act and/or present themselves as Company's representative, employees or any type of partners.
- 9.6. You are responsible for any tax obligations arising from the Referral Reward.

### 10. Disclaimer

- 10.1. The Referral Reward is provided as a promotional activity and should not be considered an endorsement of trading or investment decisions.
- 10.2. Trading in financial instruments carries a high level of risk and may not be suitable for all investors. You may lose more than your initial investment. Please ensure You understand the risks involved and seek independent advice if necessary. By accepting the Referral Reward, you acknowledge and agree that you are solely responsible for your trading decisions and outcomes.

# 11. Governing Law

- 11.1. This Policy shall be governed by and construed in accordance with the laws of Cyprus.
- 11.2. Any disputes arising out of or in connection with this Policy shall be subject to the exclusive jurisdiction of the courts of Cyprus.

#### 12. Amendments

- 12.1. The Company may update this Policy from time to time. Any updates will be published on Our website and will take effect immediately upon publication.
- 12.2. The Company reserves the right to make the following changes on a per-referrer basis:
  - changes to the form of the Referral Reward, including converting Trading Credits into withdrawable funds, or changes to the amount awarded to the Referrer per eligible Referral:
  - changes to the maximum number of Referral Rewards a Referrer may be eligible to receive per referral link;
  - changes to the qualification period required before the Reward is credited.
